I FURTHER CERTIFY, That the persons executing the articles and their associates and
successors are hereby constituted a corporation, by the name hereinbefore stated, for
perpetual existence from the date hereof, with its registered office in this State located at

and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative
Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION
of
IDAHO ATHLETIC HALL OF FAME, INC.

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, natural citizens, being over the age of 21 years, and all being residents of and domiciled within the State of Idaho, acting as incorporators of a corporation under the provisions of Chapter 10, Title 30, Idaho Code, do hereby adopt the following Articles of Incorporation for such corporation.

I.

The name of this corporation shall be

IDAHO ATHLETIC HALL OF FAME, INC.

II.

The period of duration for said corporation shall be perpetual.

III.

The purposes for which this corporation is organized and formed are to stimulate interest and participation in all types of sports and athletics, to work with state universities, private universities or colleges, public high schools and athletic clubs or athletic groups for the purposes of fostering public interest and participation in various athletic and sporting contests. To promulgate and promote public recognition of individual athletes and aid and assist in their participation within athletic contests and athletic programs. To do all things necessary for the accomplishment thereof upon a non-profit basis.

IV.

No member, officer or director of this corporation shall receive any pecuniary gain or reward from said corporation and that any funds,

monies or sums derived by said corporation by way of donation or otherwise, shall be used exclusively for the advancement and recognition of athletes and athletic programs within the State of Idaho.

That in the event of the dissolution or termination of this corporation, any and all assets, properties, monies or credits held by said corporation shall thereupon revert to and become absolutely the property of the University of Idaho at Moscow, Idaho.

V.

This corporation shall not issue any capital stock, but shall issue membership certificates to each member hereof. Said certificates of membership cannot be assigned or transferred so that the transferee becomes a member of the corporation except by resolution of the Board of Directors and under such rules and regulations as the by-laws of this corporation shall prescribe.

Any natural person, corporation, association and/or co-partnership may become a member hereof upon complying with the terms and conditions of membership as shall be fixed by the by-laws of said corporation. No person shall be denied membership in said corporation solely by virtue of race, creed or color.


