

Articles of Incorporation of the Albion,

Idaho Creamery Company.

Know all men by these presents that we the undersigned have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

And we hereby certify:

I.

That the name of said corporation is the Albion, Idaho, Creamery Company.

II

That the purposes for which it is formed are to carry on the business of manufacturing and selling butter and cheese, and other creamery products.

III.

That the place where its principal business is to be transacted, shall be at the town of Albion, Cassia County, State of Idaho.

IV.

That the term for which it is to exist is fifty years from and after the date of its incorporation.

V.

That the number of its Directors shall be five (5) and that the names and residences of those who are appointed for the first year are:

E. F. Mahoney, of Albion, Cassia County, Idaho,

Mrs. Marie Berstrom, of Albion, Cassia County, Idaho.

John P. Hansen, of Albion, Cassia County, Idaho.

Thomas E. Harper, of Albion, Cassia County, Idaho, and

D. C. Loveland of Albion, Cassia County, Idaho.

VI.

That the amount of capital stock of this corporation shall be five-thousand dollars, (\$5000.00) divided into fifty shares of the par value of one hundred dollars (\$100.00) each.

VII.

That the amount of said capital stock which has been actually subscribed is three thousand six hundred and fifty dollars. (\$3650.00)
