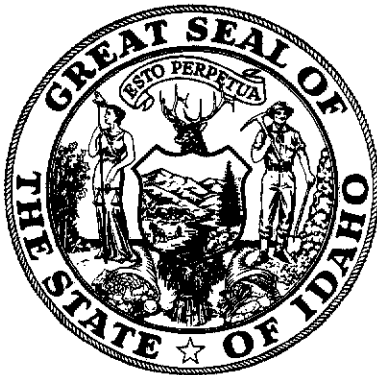
CERTIFICATE OF INCORPORATION OF

The undersigned, a natural person of legal age, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following articles of incorporation for such corporation:

FIRST: The name of the corporation is: GloBil Inc.

Second: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

To engage in the business of a wholesale food and beverage distributor, and to engage in and do all lawful acts concerning any and all lawful business for which the corporation may be organized under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have the authority to issue is 1,000 shares of common stock, without par value.

FIFTH: Provisions granting the shareholders the preemptive right to acquire additional shares of the corporation are: None.
