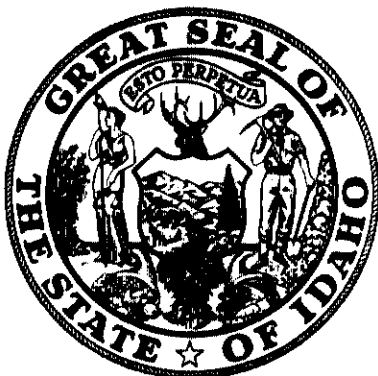
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
OF
SRG TECHNOLOGIES, INC.

WE, the undersigned, incorporated for the purposes of forming a corporation under and pursuant to Title 30, Chapter 1, of the IDAHO CODE, do hereby certify the following:

ARTICLE I

The name of the Corporation shall be:

SRG TECHNOLOGIES, INC.

ARTICLE II

The duration of this Corporation shall be perpetual.

ARTICLE III

The purpose of this Corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of Idaho.

ARTICLE IV

The location of the registered office of this Corporation in the State of Idaho shall be:

ARTICLE V

The aggregate number of shares which this Corporation shall have the authority to issue is One Thousand (1,000) Shares, with a par value of One Hundred Dollars (\$100.00) per Share, having an aggregate par value of One Hundred Thousand Dollars (\$100,000.00) which shall be known as common stock.

ARTICLE VIII

All or any portion of these ARTICLES OF INCORPORATION may be amended by the affirmative vote of the holders of a majority of the stock entitled to vote.


ARTICLE IX

The management of this Corporation shall be vested in a Board of Directors consisting of not less than one (1) or more than seven (7) directors to be elected at the annual meeting of this Corporation.

ARTICLE X

The Officers of this Corporation shall consist of a President, a Vice-President, a Secretary, and a Treasurer, and any two (2) of the Officers, except those of the President and Secretary, may be held by the same person, unless provided otherwise by law.
