RE: Use of the Word "Bank" in Company Name in Idaho – "Bobanks Holdings, LLC"

Dear Mr. Thomas:

The Idaho Department of Finance (Department) received your email on November 8, 2022, requesting approval to register the business name "Bobanks Holdings, LLC" (Bobanks) as a foreign limited liability company in the state of Idaho. You stated in your email that Bobanks is not associated with banking. You explained that Bobanks is merely a professional employer organization that processes employee payroll for Idaho business, Genesis Partners, LLC (Genesis), which is a non-medical home care service for the elderly and incapacitated. We understand from your email that Bobanks does not advertise to the public and that the only people that see the name "Bobanks Holdings, LLC" are the employees named on the check statements.

Idaho Code § 26-1202 generally prohibits persons from advertising or transacting business in this state under a name or title containing the word "bank," "banker," or a word or words of similar import, unless the person holds a banking charter. The Director of the Department may grant a waiver to allow the use of the word "bank," "banker," or words of similar import in certain circumstances. The waiver may be granted if:

- (a) The person is not engaged in banking or trust business;
- (b) The name or title used is not likely to deceive or mislead an individual to believe that the person is engaged in banking or trust business;
- (c) The name or title, or a name or title similar to it, is not already used by another person doing business in this state; and
- (d) The name or title does not suggest or imply that the person is engaged in unlawful conduct.
