ARTICLES OF INCORPORATION

OF

DRIFTWOOD POINT COOPERATIVE ASSOCIATION, INC.

The following Articles of Incorporation are hereby adopted pursuant to the Idaho Non-Profit Corporation Act.

ARTICLE I.

The name of this corporation is Driftwood Point Cooperative Association, Inc.

ARTICLE II.

This is a non profit corporation.

ARTICLE III.

This corporation shall have perpetual duration.

ARTICLE IV.

The purposes and objects for which this corporation is formed are the following:

- 1. To develop a sewage treatment system including construction and installation of service and transportation lines and a community sewage treatment and disposal site.
- 2. To undertake and conduct any other community non-profit development for the mutual benefit of members.

ARTICLE V.

This is a membership corporation and the management of its affairs is vested in the members as provided by Idaho Code Sec. 30-314(c). The membership fees and conditions shall be established by the By-Laws.

ARTICLE VI.

The street address of the registered office and the registered agent are Michael C. Young, 4975 Anne Street, Coeur d'Alene, ID 83814. Michael C. Young is also the incorporator of Driftwood Point Cooperative Association, Inc.

ARTICLE VII.

The corporation shall have the following powers:

- 1. To sue and be sued before competent tribunals at the will of the directors or membership.
- 2. To own, buy, sell, lease, assign, mortgage, hypothecate and by all lawful acts, deal in real and personal property, including the erection and maintenance of buildings and the obtaining of personal property which would further the interests of the corporation.
- 3. To establish bank accounts, charge dues and fees, solicit money, engage in non-profit enterprises, raise money, hire and fire employees, make loans, acquire loans, deal in choses of action, and engage in any enterprises connected to the purposes herein established in any lawful way, so long as the same are of a non-profit nature.
- 4. To issue bonds, notes and other instruments of debt and to deal in the stocks, bonds, notes, mortgages and debt instruments of any other person, firm or corporation.
- 5. To join or merge with any other group, firm association or corporation, non-profit in nature, whose purposes are not in conflict with those herein stated.
