KNOW ALL PERSONS BY THESE PRESENTS: That we, the undersigned, being natural persons of full age and citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, pursuant to the laws of the State of Idaho, do hereby certify as follows:

ARTICLE I.

The name of the corporation shall be Jacobsen Sound, Inc.

ARTICLE II.

The corporation shall have perpetual existence.

ARTICLE III.

The purposes for which said corporation is formed are:

- A. To operate a business dealing with the sales, installation and repair of sound reinforcement systems and components.
- B. The transaction of any or all lawful business for w_{fi} corporations may be incorporated.

ARTICLE IV.

The aggregate number of shares of capital stock which

this corporation shall have authority to issue shall be 50,000 shares of \$1.00 par value common stock.

ARTICLE V.

The location and post office address of the corporation's registered office and primary office of business shall be 335 Lone Star Road, Nampa, Idaho, 83651. The registered agent shall be Danny L. Jacobsen, 335 Lone Star Road, Nampa, Idaho 83651.

ARTICLE VI.

The Board of Directors shall consist of two (2) directors, but during their term of office, or thereafter, the number of directors may be increased or decreased from time to time as may be provided by the By-Laws; provided, however, that the number of directors constituting the Board of Directors shall not be less than two (2) nor more than six (6).

ARTICLE VIII.

The Board of Directors, by a majority vote, shall have he power to adopt By-Laws, and to repeal and amend By-Laws.

ARICLE IX.

No contract or other transaction between the e upocation and any other corporation, whether or not a majority of he *hares of the capital stock of such other corporation is owned by the corporation, and no act of the corporation, shall be in any way affected or invalidated by the fact that any of the directors of the corporation are pecuniarily or otherwise interested in, or are directors or officers of such other comporation; any director individually, or any firm of which such director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of the corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors; and the director of the corparation who is so interested, may be counted in determining the existence of a quorum at any meeting of the Board of Directors of the corporation which shall authorize such contract or transaction, with like force and effect as if he were not

such director or officer of such other corporation, or not so inverested.
