Ralph C. Mathison, acting as the incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I.

The name of the corporation is **PRAIRIE BOWL, INC.**

ARTICLE II.

The corporation is organized for the purpose of owning, operating and managing real and personal property; engaging in the general business of acquiring, building, maintaining and operating bowling lanes and other activities ancillary thereto; and for the purpose of conducting any other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III.

The powers of the corporation shall include the following but now be limited thereto:

- (a) To have perpetual succession by its corporate name;
- (b) To sue and be sued, complain and defend in the corporate name;
- (c) To have a corporate seal which may be altered at pleasure;
- (d) To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use and otherwise deal in and with real or personal property, or any interest therein, wherever situated;
- (e) To sell, convey, mortgage, pledge, lease, exchange, transfer, and otherwise dispose of all or any part of its property and assets;
- (f) To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes and bonds and other obligations, and secure any of its obligations by mortgage or pledge all or any of its property, franchises and income;
- (g) To have and to exercise any and all powers necessary or convenient to effect its

purposes, specifically including, but not limited to the powers enumerated under Idaho Codes 30-1-302, as it presently exists together with any powers which may be hereinafter added to said statute.

ARTICLE IV.

The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1,000) each with a par value of Five Hundred Dollars (\$500.00). There shall be issued only one class of shares which shall be known as the common stock of the corporation.

ARTICLE V.

The address of the initial registered office of the corporation is: Prairie Bowl, Inc., % W. W. Longeteig, 120 West Main Street, Craigmont ID 83523, and the name of its initial registered agent at such address is Wilfrid W. Longeteig.

ARTICLE VI.
