# ARTICLES OF INCORPORATION OF RAPID LIGHTNING COMMUNITY CENTER COMPANY

WE, the undersigned, do hereby associate ourselves together for the purpose of forming a nonprofit corporation under the statutes of the State of Idaho.

#### ARTICLE ONE

NAME

The name of the corporation is RAPID LIGHTNING COMMUNITY CENTER COMPANY.

#### ARTICLE TWO

#### NONPROFIT CORPORATION

The corporation is a nonprofit corporation. No dividends or pecuniary profits shall be declared or paid to the members thereof.

#### ARTICLE THREE

#### DURATION

The period of duration of this corporation is perpetual.

## ARTICLE FOUR PURPOSES

The purposes for which this corporation is organized is to effect an association of all persons interested in helping to develop and maintain a community center; to promote sociability and friendship among it's members; to effect the establishment and operation of facilities for the exclusive use, pleasure, recreation, education, and entertainment of members and guests; to purchase, lease, hold, sell, develop, erect, build, mortgage, deed in trust, convey, or otherwise acquire and dispose of personal and real property, and to maintain and operate same for the use and enjoyment of all the members of the corporation, subject to rules, regulations, and restrictions as set forth in the bylaws of this corporation and as determined by action of the board of directors in regular meeting; to do all and everything necessary, suitable and proper for the accomplishment of any of the purposes or attainment of any of the objects heretofore setforth or mentioned, either alone or in association with other individuals, corporations, or partnerships, including but not limited to the county, state, federal, and municipal bodies and

authorities; and in general, to do and perform such things and acts and transact such business in connection with the foregoing objects not inconsistent with the laws of the State of Idaho or the objects of the corporation.

#### ARTICLE FIVE

#### **POWERS**

The corporation shall have all powers given and authorized to nonprofit corporations under the statutes of the State of Idaho.

#### ARTICLE SIX

#### NONSTOCK CORPORATION

The corporation shall be nonstock.

#### ARTICLE SEVEN

#### NONLIABILITY OF MEMBERS

The members of the corporation shall not be personally liable for the debts, liabilities or obligations of the corporation.

#### ARTICLE EIGHT

#### DIRECTORS
