Pursuant to the provisions of Sections 30-1-61 and 30-327 of the Idaho Business Corporation Act and the Idaho Non-Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation: <u>FIRST</u>: The name of the corporation is THE AMERICAN STUDIES

INSTITUTE, INC.

<u>SECOND</u>: The following amendments of the Articles of Incorporation were adopted by the incorporator of the corporation on July 1, 1983, in the manner prescribed by the Idaho Business Corporation Act and the Idaho Non-Profit Corporation Act:

The Articles of Incorporation of The American Studies Institute, Inc., are hereby amended in their entirety to read as follows:

The undersigned acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is THE AMERICAN STUDIES INSTITUTE, INC.

SECOND: The Period of its duration is perpetual.
