ARTICLES OF INCORPORATION

OF

SEPARATION SYSTEMS, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Separation Systems, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: Providing of services and development of products in the fluids separation area, together with the transaction of all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, Section 30-1-301.

FOURTH: The number of shares which the corporation shall have authority to issue is ten thousand shares of \$100 par value common stock. The shares of the corporation shall consist of a single class - voting common; with the corporation reserving the right to later amend these Articles of Incorporation to provide for other classes of stock.

FIFTH: The corporation elects to have full pre-emptive rights as to issuance of stock, as provided under the Idaho Business Corporation Act, Section 30-1-630.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the By-Laws of the corporation, adopted pursuant to the Idaho Business Corporation Act, Section 30-1-206, including provision for restriction on transfer of shares, as provided in Idaho Business Corporation Act, Section 30-1-627.

SEVENTH: The address of the initial registered office of the corporation is 4412 South 5th, Pocatello, Idaho 83204, and the name of its initial registered agent at such address is E.D. McCasland.


EIGHTH: The number of directors constituting the initial Board of Directors of the corporation is four and the names and addresses of the persons who are to serve as directors until the next annual meeting of shareholders or until their successors are elected and shall qualify are:
