

Articles of Incorporation

These articles are constructed according to the guidelines of Idaho State under the provisions of Title 30, Chapter 1 dealing with the formation and organization of Inc. companies.

1. The name of the corporation is Bath Master Inc.
2. The number of shares the corporation shall be authorized to issue is fifty thousand (50,000) shares of capital stock. Each share shall be common stock, having a par value of one and no/100 (\$1.00) dollars. All capital stock shall be fully paid and not liable to any call or assessment.


