AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for Perpetual Existence from the date hereof, with its registered office in this State located at St. Maries, Idaho in the County of Benevah and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

 OF

ST. MARIES AMERICAN LEGION BASEBALL, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all full age citizens of the United States have this day voluntarily associated ourselves together for the purpose of forming a non-profit, social, benevolent and charitable corporation under the laws of the State of Idaho, in compliance with Chapter 11, Title 30, Idaho Code, and for such purpose we hereby make, execute and adopt the following Articles of Incorporation:

ARTICLE I

Name

The name of this corporation shall be "ST. MARIES AMERICAN LEGION BASEBALL, INC."

ARTICLE II

Location

The location and post office address of the registered office of this corporation in Idaho shall be St. Maries, Idaho.

ARTICLE III

Non-Profit Corporation

This corporation is organized not for profit and this corporation shall not afford pecuniary gain, incidentally or otherwise to its members, officers or directors and no part of the corporation's net earnings shall ensue to the benefit of any member or director.

ARTICLE IV

Purposes

The purposes and objects for which this corporation is formed are:

(1) To do all and every legal act and thing of whatever nature to promote and conduct the American Legion Baseball program with the

membership area of St. Maries Post No. of the American Legion, Inc. and in accordance with the rules and regulations established by the National Headquarters of the American Legion and the Department of Idaho of the American Legion. Without limitation on the foregoing, to provide equipment and uniforms, to maintain baseball fields, club houses, and other facilities, necessary to conduct the American Legion Baseball program, to best promote the common good and general welfare of boys and the communities they reside and participate both within and without the State of Idaho.

- (2) To provide a means of teaching boys leadership, character training, and civic consciousness acquired through the constructive training, behaviour guidance, discipline and competitive spirit, acquired by a boy who participates in American Legion Baseball.
- (3) To receive donations, gifts and contributions from any person, firm or corporation or other source to carry out the purposes of the corporation, and to create and maintain funds for such purposes.
- (4) To promote and conduct district, state, regional and national American Legion Baseball tournaments.
- (5) To issue by publication or otherwise, baseball programs, items of interest, notices, manuscripts, circulars and other writings, and sell advertising in the same, for the benefit of its members, affiliated clubs and all boys taking part in its program.
- (6) To acquire, hold, own, use and dispose of, in any legal manner, all real and personal property whatsoever, as may be reasonably necessary for the purpose of carrying into effect any one or more of the objects herein mentioned, and to mortgage, hypothecate, pledge, sell and otherwise dispose of said property, to borrow money and to do all acts, and to make, execute and deliver all necessary instruments for the carrying on of the said purposes; to enter into contracts, to borrow money, lend money and to evidence the indebtedness of the corporation by notes, bonds or other instruments and to secure the same by pledge, mortgage, trust deed or other instruments as to the corporation may seem proper.
- (7) To acquire, own, use and dispose of such real and personal property, and to conduct its affairs and activities either within or without the State of Idaho, as shall be in the best interests of its members.
- (8) To operate or lease food and beverage concessions before, during and after all American Legion Baseball games.
- (9) To sponsor, promote, engage in and conduct entertainments, amusements, shows, projects and diversions to provide capital and to defray the costs and expenses of the corporation and its undertakings.
- (10) To do any and all things convenient and incidental to the purposes herein expressed, and generally to have and to exercise all such powers as are by law conferred on corporations of like character through this corporation or by and through, principals, agents, attorneys, trustees, lessors, lessees or otherwise, either alone or in connection with others.

ARTICLE V.

That the duration of this corporation shall be unlimited and

perpetual.

ARTICLE VI.

Seal

This corporation shall have no seal.

ARTICLE VII.

Capital Stock

The corporation shall have no authority to issue capital stock.

ARTICLE VIII.

ARTICLE IX.

The number of directors of this corporation shall be not less than seven (7) nor more than one hundred (100); and their number, term of office, and manner of elections, time and place of meetings, and powers of directors, and their duties, shall be such as are prescribed by the by-laws of this corporation.

ARTICLE X.

Membership

Members shall be selected on a non-partisan and non-sectarian basis. All other conditions of membership shall be determined by the by-laws of the corporation; however, the rights and interests of all members shall be equal, and no member shall have or acquire greater interest therein than any other member.

ARTICLE XI.

Incorporators' Meeting

The said incorporators held a meeting at 722 Main Avenue, St. Maries, Idaho, on the 5th day of May, 1975, at 7:30 P.M.; that a notice of said meeting was published as required by law in the St. Maries Gazette Record, on April 17, 1975, April 24, 1975 and on May 1, 1975; and that a notice of the same was posted at the office of Thomas C. Morris, Attorney at Law, 722 Main Avenue, St. Maries, Idaho, for the same length of time; that proof by certificate of such publishing and posting is hereto attached as Exhibits "A" and "B"; that at such meeting the directors, enumerated in Article VIII

herein, were elected to serve until the next annual meeting; all of the incorporators and a majority of the members were present at said meeting and voted and the election was unanimous; that the verification of such facts by the presiding officers is attached hereto and made a part hereof as Exhibit "C".

ARTICLE XII.

By-Laws

The by-laws of this corporation were adopted at the incorporators' meeting by the unanimous vote of all those present, and thereafter may be amended by a two-thirds (2/3) vote of all members present at any meeting of the club, providing a two weeks' written notice of the proposed amendment shall have been given the membership prior to the meeting.

ARTICLE XIII.

Dissolution

Upon termination or dissolution of this corporation for any reason whatsoever, or by action of the State of Idaho, then, in that event, all then existing assets of this corporation shall be distributed to St. Maries Post No. 25, American Legion Incorporated, a non-profit corporation formed under the laws of the State of Idaho, to be used for the purposes of promoting the welfare of boys through youth baseball programs in the area generally known as the St. Maries Valley.
