CERTIFICATE OF INCREASE OF CAPITAL STOCK.

We the undersigned,, C. G. Westerberg, President and Peter Yorgensen, Secretary, of the Rudy Irrigation Canal Company, a Corporation, the certificate of Incorporation of which was filed for record with the recorder of Fremont county, Idaho on the 22nd day of January, 1904 and recorded in book B of Incorporations, and with the Secretary of State of the state of Idaho on the 27th day of January, 1904 and recorded in book O, do hereby certify to the following to wit:

That at a meeting of the board of directors of the said corporation a majority of the directors voted to call a meeting of the stockholders of the said corporation to vote upon the question of increasing the capital stock of the company, and accordingly due notice was served on each stockholder that meeting would be held at the company's place of business on the 3rd day of February 1906. There was represented 390 shares of stock at the meeting, which convened according to notice, and a motion was duly made and seconded, that the Capital stock of the company be increased from Thirtyfive hundred Dollars, (\$3500.00) to Seven thousand Dollars (\$7000.00). And 390 shares of stock voted for such increase and none voted to oppose it. We do also certify that we were chairman and secretary of meeting.
