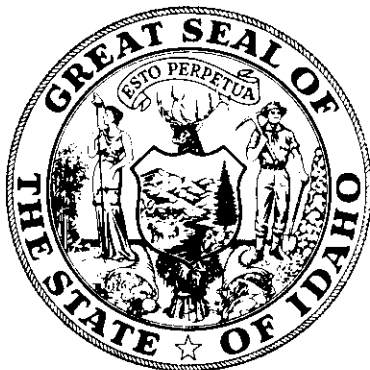

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to the Articles of Incorporation.

FIRST: The name of the corporation is currently Solar Reflector Corp.

SECOND: The following amendments of the Articles of Incorporation were adopted by Molecular Development Corporation as sole shareholder of the corporation on March 30, 1984 in the manner prescribed by the Idaho Business Corporation Act.

"FIRST: The name of the corporation is S.R.C., Inc."
