





To the Secretary of State of Idaho.

Pursuant to Section 30-1-110, **Idaho Code**, the undersigned Corporation hereby applies for a Certificate of Authority to transact business in your State, and for that purpose submits the following statement:

1. The name of the corporation is UNITED STATES SOCCER FEDERATION
2. *The name which it shall use in Idaho is UNITED STATES SOCCER FEDERATION
3. It is incorporated under the laws of Utah
4. The date of its incorporation is 28 December 1984 and the period of its duration is Perpetual



9. The corporation accepts and shall comply with the provisions of the Constitution and the laws of the State of Idaho.




