


ARTICLES OF INCORPORATION

WE, the undersigned, have voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Nevada relating to private corporations, and to that end do hereby adopt Articles of Incorporation as follows:

ARTICLE ONE

NAME

The name of the corporation is SATELLITE MINING, INC.

ARTICLE TWO

LOCATION

The principal office of the corporation is to be located at The Ashdown Mine, Post Office Box 32, Denio, Humboldt County, Nevada 89404.

ARTICLE THREE

PURPOSE
