

**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
LOJEK, GABBERT & STROTHER CHARTERED**

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, LOJEK, GABBERT & STROTHER CHARTERED has adopted the following Articles of Amendment to its Articles of Incorporation.

I.

The name of the corporation is LOJEK, GABBERT & STROTHER CHARTERED.

II.

The following amendments to the Articles of Incorporation were adopted by the unanimous consent of the shareholders of the corporation on September 26, 1994, in the manner prescribed by the Idaho Business Corporation Act:

Article I of the Articles of Incorporation shall be amended to read as follows:

I.

The name of the corporation shall be LOJEK & STROTHER CHARTERED beginning on October 1, 1994.

III.

The number of shares of the corporation outstanding at the time of such adoption was 100, and the number of shares entitled to vote thereon was 100.

IV.

The number of shares voted for such amendment was 100 and the number of shares voted against such amendment was 0.


