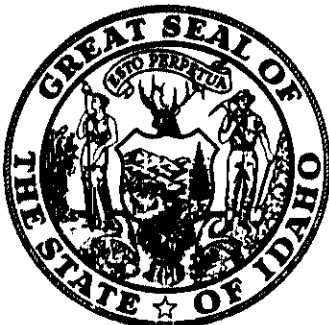
### CERTIFICATE OF AMENDMENT OF


**ARTICLES OF AMENDMENT**




