ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned incorporators, all being residents of the State of Idaho, do hereby certify that we have this day voluntarily associated ourselves together for the purpose of forming a corporation under and in compliance with the laws of the State of Idaho, and do hereby adopt the following Articles of Incorporation, to wit;

ARTICLE I

The name of this corporation shall be and is "VALLEY AIR SERVICE, INC."

ARTICLE II

The purposes for which this corporation is formed are the following;

(a) To engage in the business of owning, operation, and/or otherwise dealing in the business of an aircraft flight service, including but not limited to the furnishing of any and all services connected with airport and aircraft operation.

(b) To engage in the business of buying and selling airplanes.

(c) To engage in the business of owning and operating an airport and otherwise dealing in the business connected with airport maintenance and operation.

(d) To operate Aerial application aircraft, Charter aircraft, Air taxi service, Flight school, and to engage in any other business in which an aircraft may be used.

(e) To buy, sell, own, hold, lease, improve and deal in real estate or personal property of any type and description, whether or not the same is used in connection with any of the purposes of the corporation listed herein.

(f) To own, operate and maintain a business and all facilities necessary for the maintenance and re-building of any and all types of aircraft.

(g) To acquire, own, hold, lease, build and/or erect any and all buildings, structures and plants that may be deemed suitable to the furtherance of the foregoing or any purposes for which the corporation is formed, and to operate, manage, control, rent, sell or otherwise dispose of the same.

(h) To incur indebtedness in such amount as may be deemed necessary, and to borrow money; to evidence such or any indebtedness by the bonds or other written obligations of the corporation; and to secure the payment thereof by mortgage, deed of trust, or other form of encumbrance upon all or any part of the property, real or personal, of the corporation, whether owned at the time or afterwards to be acquired.

(i) To carry on any activity or activities that might be related to any of the above described powers of the said corporation.

(j) To do such business not only within the State of Idaho, but in any part of the world, as may be deemed and determined by the board of directors from time to time, without limiting any of the objects and purposes aforesaid. It is expressly declared that the corporation shall have and possess all the powers specifically hereinabove enumerated, and also any and all such additional or further powers as may be incidental

to the carrying out of the same, and also such other rights, privileges and powers granted by the laws of this state to corporations, except such as may be inconsistent herewith; the intention hereof is expressly declared to be that the powers of this corporation as expressed herein shall be construed as a grant of general powers and not in any sense as a grant of special or limited powers.

(k) To acquire, invest in, own and dispose of the capital stock of other corporations, and the business property and assets of any person, co-partnership or corporation.

#### ARTICLE III

The ~~principal~~<sup>Registered</sup> place of business and the place where the principal office of the corporation shall be is hereby designated as Hubler Field, Rt. 3 Box 62, Caldwell, Idaho, 83605. The Registered Agent is William F. Hubler.

#### ARTICLE IV

The existence of the corporation shall be perpetual.

#### ARTICLE V

The number of directors of this corporation is hereby fixed at three.

#### ARTICLE VI

Stock holders of this corporation shall be limited to no more than ten (10) in number, and no stock holder shall dispose of his or her stock without first offering it to the other stock holders for a period of not less than 30 days. Any new stock holders shall be approved by the Board of Directors.

#### ARTICLE VII

The capital stock of this corporation shall be One Hundred Thousand Dollars, to be divided into 1,000 shares of the par value of \$100.00 per share.

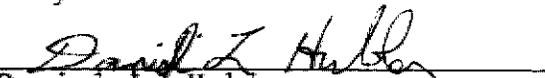
ARTICLE IX
