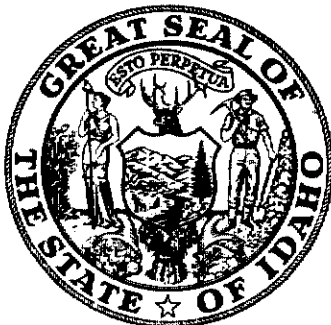

# ARTICLES OF INCORPORATION

OF

M R & R FARMS, INC.

The undersigned, acting as incorporators of M R & R Farms, Inc., a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation:

**FIRST:** The name of the corporation is M R & R Farms, Inc.

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purpose or purposes for which the corporation is organized are:

(A) To acquire farm property and other real estate, by purchase, lease or otherwise, to improve and develop the same, and thereon to plant, sow, cultivate and harvest grains, hay, vegetables, and all kinds of farm produce and products of the soil. In general, to conduct the business of farmers and to do everything incidental or conducive to the full accomplishment of the foregoing objects.

(B) To carry on any other kind of business or business activities that the Board of Directors may from time to time deem to be advisable or proper in connection with the business.

(C) To purchase, lease, own, sell, mortgage, sublease, and otherwise acquire lands, buildings, easements of property, real and personal, which may be requisite for the purposes or are

2 objects of this corporation, and to enter into, make, perform and  
3 carry out contracts of every sort and kind with any person, and to  
4 acquire and take over the good will, property, rights, franchises

6 association, or corporation, either wholly or in part, and to pay  
7 for the same in cash, stocks or bonds of the corporation, or  
8 otherwise.
