Pursuant to the provisions of Section 30-3-91 of the Idaho Nonprofit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is The Arc, Inc.

SECOND: The following amendment of the Articles of Incorporation were adopted at a meeting (at which a quorum was present) of the members of the undersigned corporation held on June 25, 1996 in the manner prescribed by the Idaho Nonprofit Corporation Act.

THIRD: The number of members of the corporation at the time of such adoption was <u>ONE HUNDRED ELEVEN</u>; and the number of votes entitled was <u>ONE HUNDRED ELEVEN</u>.

FOURTH: The number of members who voted for such amendment was <u>SEVENTEEN</u>; and the number of members who voted against such amendment was <u>NONE</u>. Such amendment received a majority of the votes which members present at such meeting in person were entitled to cast.
