ARTICLES OF INCORPORATION
OF
WAGNER PETROLEUM COMPANY, INC.

We, the undersigned, being two or more natural persons of full age, both of whom are citizens of the United States or of its territories or possessions, have this day voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and to that end hereby adopt articles of incorporation as follows:

ARTICLE ONE

NAME

The name of the corporation is Wagner Petroleum Company, Inc.

ARTICLE TWO

DURATION

The duration of the corporation is perpetual.

ARTICLE THREE

PURPOSES

The purposes of the corporation are to buy, sell, dispose of, and deal in gasoline and other petroleum products and use all such equipment and motor vehicles incident to the distribution of such products, and to have and to exercise all the powers now or hereafter conferred by the laws of the State of Idaho upon corporations organized pursuant to the laws under which the corporation is organized and any and all acts amendatory thereof and supplemental thereto.

ARTICLE FOUR

STOCK

The aggregate number of shares which the corporation shall have authority to issue is 1,000, of one class only. All such shares are without par value.

ARTICLE FIVE

LOCATION AND REGISTERED AGENT
