
### CERTIFICATE OF AMENDMENT OF


**ARTICLES OF AMENDMENT**

The undersigned, being the President and majority shareholder of Brady Lerma Thomas, Chartered, a corporation organized under the laws of the State of Idaho, does hereby adopt the following Amendment to the Articles of Incorporation of Brady, McDaniel & Matthews, Chartered:

1. Change the name of the corporation from Brady Lerma Thomas, Chartered to: **BRADY LERMA, CHARTERED**, effective February 1, 1993.




