ARTICLES OF INCORPORATION

OF SECRETARY OF

STATE

POWDER CORDS, INC.

KNOW ALL PERSONS BY THESE PRESENTS: That we,
FREDERICK SMOLE, JAMES S. DIEDERICH, RODERICK A. STOLZ, and
LINDA D. SMOLE, each being a natural person of full age and
a citizen of the United States of America, have this day
voluntarily associated ourselves together for the purpose of
forming a corporation under and pursuant to the provisions
of Title 30, Idaho Code, and we do hereby certify as follows:

FIRST

That the corporate name of this corporation shall be:

POWDER CORDS, INC.

SECOND

That the purposes and objects for which said corporation is formed are as follows:

- (a) To have perpetual succession by its corporate name unless a limited period of duration is stated herein.
- (b) To sue and be sued, complain and defend, in its corporate name.
- (c) To have a corporate seal which may be altered at pleasure, and to use the same by causing it, or a facsimile thereof, to be impressed or affixed or in any other manner reproduced.
- (d) To purchase, take, receive, lease, or otherwise acquire, own, hold, improve, use and otherwise deal in and with, real or personal property, or any interest therein, wherever situated.
- (e) To sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of all or any part of its property and assets.

- (f) To lend money and use its credit to assist its employees.
- (g) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, other domestic or foreign corporations, associations, partnerships, or individuals, or direct or indirect obligations of the United States or of any other government, state, territory, governmental district or municipality or of any instrumentality thereof.
- (h) To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises and income.
- (i) To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.
- (j) To conduct its business, carry on its operations and have offices and exercise the powers granted by this act, within or without this state.
- (k) To elect or appoint officers and agents of the corporation, and define their duties and fix their compensation.
- (1) To make and alter bylaws, not inconsistent with its articles of incorporation or with the laws of this state, for the administration and regulation of the affairs of the corporation.
- (m) To make donations for the public welfare or for charitable, scientific or educational purposes.

- (n) To transact any lawful business which the board of directors shall find will be in aid of governmental policy.
- (o) To pay pensions and establish pension plans, pension trusts, profit sharing plans, stock bonus plans, stock option plans and other incentive plans for any or all of its directors, officers and employees.
- (p) To be a promoter, partner, member, associate, or manager of any partnership, joint venture, trust or other enterprise.
- (q) To have and exercise all powers necessary or convenient to effect is purposes.

The foregoing clauses, by reason of the specific enumeration of such powers, shall not be held to restrict the power of the corporation to do any act or thing within the purview of its general purposes.

THIRD

This corporation shall have perpetual existence.

FOURTH

SIXTH

The capital stock of this corporation shall consist of two hundred (200) shares of common stock, having a par value of One Hundred Dollars (\$100.00) per share, and an

aggregate par value of Twenty Thousand Dollars (\$20,000.00), each of which such shares shall be non-assessable when fully paid for.

The capital stock of this corporation shall not be divided into classes, but shall consist of one class only, that being common stock; and each share of stock shall be entitled to one vote in all matters wherein the shareholders of the corporation shall be entitled to vote, and each share shall in all respects be equal to every other share.

The capital stock shall be transferred only in accordance with such rules and regulations as are established by the By-Laws of the corporation, and all restrictions relative to the transfer of shares of stock of the corporation shall be noted on the stock certificates issued by the corporation.
