I.

#### II.

That the purposes for which it is formed are to acquire, own, hold, operate and maintain water, water rights, dams, ditches, flumes, reservoirs, acqueducts, and systems, for the use, operation, and distribution of water for agricultural and power purposes and for domestic uses at and in the vicinity of Cove, That Mcher, and Cleveland Post Offices Bannook County, Idaho.
