

ARTICLES OF AMENDMENT OF
GIACOBBI, HALE & EDDY, INC.

ARTICLE I

NAME

The name of this corporation is GIACOBBI, HALE & EDDY, INC.

ARTICLE II

AMENDMENTS

The Articles of Incorporation of said corporation, as amended by the Articles of Amendment, filed June 30, 1982, in the office of the Secretary of State, shall be further amended as follows:

a. Article I of the Articles of Incorporation shall be deleted and the following substituted therefor:

"1. Name. The name of the corporation is GIACOBBI REALTY, INC."

ARTICLE III

DATE OF ADOPTION

The Amendments were approved by the Shareholders of the corporation at a meeting held on the 30th day of November, 1983, at which meeting there was at all times an acting quorum of the Shareholders.

ARTICLE IV

NUMBER OF SHARES OUTSTANDING

At the time of the adoption of the Amendments there were ten thousand (10,000) shares of stock of the corporation. The holder of each of these ten thousand (10,000) shares were entitled to vote on the Amendments, and all ten thousand (10,000) shares voted for the Amendments.

ARTICLE V

EFFECT ON ISSUED SHARES AND STATED CAPITAL

The Amendment does not provide for an exchange, reclassification or cancellation of issued shares, nor does it effect a change in the amount of stated capital.

The undersigned being the President and Secretary of the corporation declare under penalty of perjury that the matters set forth in the foregoing Articles of Amendment are true and correct and that these Articles of Amendment were executed on the 6th day of February, 1984, at Ketchum, Idaho.
