ARTICLES OF AMENDMENT

EARLY PARENTING SUPPORT SERVICES, INC.

Pursuant to Section 30-327 of the Idaho Non-Profit Corporations Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

The name of the corporation is EARLY PARENTING SUPPORT SERVICES, INC.

II

The following amendments to the Articles of Incorporation were adopted at a meeting of members the <u>24th</u> day of January, 1983, with a quorum present at said meeting and by a majority of those votes cast in person and by proxy at said meeting:

- (1) Resolve that Article Two of the Articles of Incorporation shall be amended by adding the following sentence: This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- (2) Resolve that Article Six of the Articles of Incorporation shall be amended to change the post office address of the registered office. Article Sixth shall henceforth read: The post office address of the corporation's registered office is 1504 Third Street North, Nampa, Idaho 83651. The registered agent at such address is Virginia Cawdery.
- (3) Resolve that Article Eight of the Articles of Incorporation shall be amended by adding the following sentence: Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of

the organization, the remaining fund shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.
