## ARTICLES OF AMENDMENT

### EARLY PARENTING SUPPORT SERVICES, INC.

Pursuant to Section 30-327 of the Idaho Non-Profit Corporations Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

#### I

The name of the corporation is EARLY PARENTING SUPPORT SERVICES, INC.

#### II

The following amendments to the Articles of Incorporation were adopted at a meeting of members the 24th day of January, 1983, with a quorum present at said meeting and by a majority of those votes cast in person and by proxy at said meeting:

(1) Resolve that Article Two of the Articles of Incorporation shall be amended by adding the following sentence: This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(2) Resolve that Article Six of the Articles of Incorporation shall be amended to change the post office address of the registered office. Article Sixth shall henceforth read: The post office address of the corporation's registered office is 1504 Third Street North, Nampa, Idaho 83651. The registered agent at such address is Virginia Cawdery.

(3) Resolve that Article Eight of the Articles of Incorporation shall be amended by adding the following sentence: Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of

the organization, the remaining fund shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.


