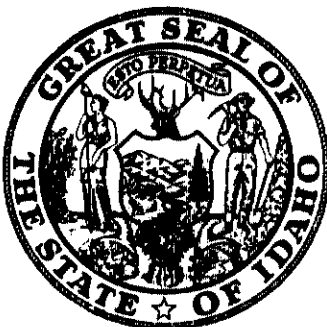
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

AVIATORS HISTORICAL FOUNDATION, INC.

KNOW ALL PEOPLE BY THESE PRESENTS: That the undersigned, residents of the State of Idaho, do hereby associate themselves together for the purpose of forming a corporation under Title 30, Chapter 10, Idaho, and hereby certify:

I.

This corporation is one which does not contemplate pecuniary gain or profit to the members thereof and is organized for nonprofit purposes and not part of any net earnings thereof shall inure to the profit of any member or other individual.

II.

The name of this corporation shall be AVIATORS HISTORICAL FOUNDATION, INC.

III.

The purposes for which this corporation is formed are:

(1) To collect and archive aviation history; and to buy, sell, lease, mortgage and exchange any and all real and personal property which may be necessary, advantageous or proper in the conduct of its purpose.

(2) In general, but in connection with the foregoing, said corporation shall have and exercise all the powers conferred by the laws of the State of Idaho, it being hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner such general powers.

IV.

The period of existence and duration of the life of this corporation shall be perpetual. If the corporation is ever dissolved, all corporate assets shall be given to a like non-profit entity.

V.

The location and post office address of the registered office of this corporation in the State of Idaho shall be 4601 Aviation Way, Caldwell, Canyon County, Idaho 83605. The registered agent shall be Carolyn G. Martell.

## VI.

Corporations, associations and partnerships, as well as persons, may become members of this corporation on terms specified by the Board of Directors of the corporation.

## VII.

The rights and interests of all members shall be equal and no member can have or acquire a greater interest therein than any other member. The corporation shall not issue any capital stock, but shall issue membership certificates to each member thereof, which certificates are not transferable but must be returned to the corporation by the member at the time of withdrawal of membership.

## VIII.

The number of directors of this corporation shall not be less than three (3) and such additional number of directors as may be determined from time to time by the by-laws of the corporation.

## IX.


