ARTICLES OF AMENDMENT

Pursuant to the Idaho Non-profit Corporation Act,

Mountain Home Performing Arts, Inc., adopts the following

articles of amendment to its articles of incorporation,

to-wit:

- 1. The name of the corporation is Mountain Home Performing Arts, Inc.
- 2. All of the members of the corporation sit as the board of directors. The following amendment to the Articles of Incorporation were adopted by the entire membership of the corporation on the 30th day of December, 1991, at a meeting held for that purpose; all of the members of the corporation were present at such meeting and that the following amendment received the unanimous vote of the members.
- 3. That pursuant to the vote of the members at said meeting, a new Article IX is hereby added to the Articles of Incorporation, said Article IX to read as follows:

IX

Upon dissolution of this corporation for any cause, after providing for the debts and obligations of the corporation, the remaining assets of the corporation of whatever nature, shall be donated to and become the property of a qualified

charitable organization to be selected by the last board of directors of this corporation. There shall be no distribution to any member or director of the corporation.
