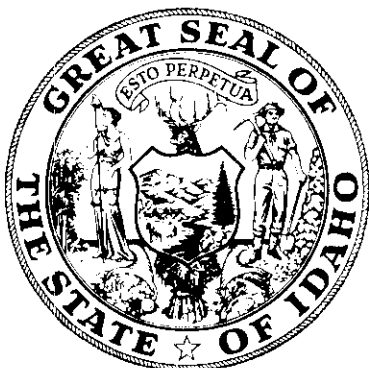

ARTICLES OF INCORPORATION OF
TENDROY ENTERPRISES, INC.

KNOW ALL MEN BY THESE PRESENTS , That the undersigned , being a natural person , of full age , and a citizen of the United States , in order to form a corporation for the purposes hereinafter stated , pursuant to the provisions of the Idaho Business Corporation Act , Title 30 , Chapter 1 , Idaho Code , does hereby certify as follows:

I.

The name of this corporation is Tendoy Enterprises, Inc.

II.

The corporation shall have perpetual existence.

III.

The purpose for which this corporation is organized is to carry on, conduct and transact any or all lawful business for which corporations may be incorporated under the laws of the State of Idaho .

IV.

There shall be but one class of stock , which shall be designated as common stock , and it shall be non-assessable . The aggregate number of shares which this corporation shall have authority to issue is 50,000.00 shares , all of which shall be without par value .

V.

The address of the registered office of the corporation is 996 South University , Blackfoot , Idaho 83221 , and the initial registered agent at said address is Thomas B . Smith .

VI.

The Board of Directors shall consist of three members to be elected annually .

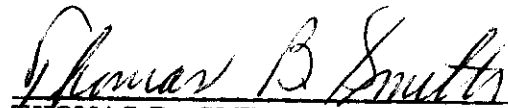
VII.

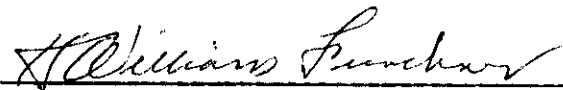
