Wildlife, Inc.**Plan of Domestication for the Foundation for Western Fish and Wildlife, Inc.**

An entity domesticating in Idaho has the option of delivering a Plan of Domestication rather than a Statement of Domestication as long as the Plan of Domestication has all of the information required by Idaho Code § 30-22-505(b). I.C. § 30-22-505(e). Accordingly, in accordance with Idaho Code § 30-22-502 *et seq.* and Idaho Code § 30-22-505(b), the following Plan of Domestication for the Foundation for Western Fish and Wildlife, Inc. is submitted.

- (1) The name of the domesticating entity is the Foundation for Western Fish and Wildlife, Inc., a non-profit corporation organized and existing under the laws of the State of Wyoming.
- (2) The name and jurisdiction of the domesticated entity is the Foundation for Western Fish and Wildlife, Inc., a non-profit corporation organized and existing under the laws of the State of Idaho.
- (3) The Foundation for Western Fish and Wildlife, Inc. is a non-profit corporation with members. All rights, duties and obligations of the members in the domesticating entity will be converted into rights, duties and obligations of the domesticated entity by resolution of the domesticating entity's board of directors, in accordance with the Bylaws of the Foundation for Western Fish and Wildlife, Inc.
- (4) The proposed public organic record of the Foundation for Western Fish and Wildlife, Inc., is the domesticated entity's Articles of Incorporation, attached.
- (5) The full text of the private organic rules of the Foundation for Western Fish and Wildlife, Inc. is the domesticated entity's Bylaws, attached.
- (6) In accordance with the Articles of Incorporation of the domesticated entity, Deb VonDeBur is designated as the registered agent of the Foundation for Western Fish and Wildlife, Inc. 2700 W. Airport Way, Boise, Idaho 83705.
- (7) This Plan of Domestication of the domesticated entity is to be effective upon the date of its filing with the Idaho Secretary of State.
- (8) Neither the Articles of Incorporation nor the Bylaws of the Foundation for Western Fish and Wildlife, Inc. provide a specific process for approval of domestication. The Wyoming Nonprofit Corporation Act does not provide a process for the domesticating

entity to follow. Wyo. Stat. Ann. § 17-19-101 *et seq.* Therefore, the Plan of Domestication must be approved in the same manner as a merger under the laws of Wyoming. I.C. § 30-22-503(a)(1)(B). In accordance with Wyo. Stat. Ann. § 17-19-1103, the Plan of Domestication was approved by a vote of the Board of Directors of the Foundation for Western Fish and Wildlife, Inc. and the Foundation for Western Fish and Wildlife, Inc. members on January 8, 2017.
