#### ARTICLES OF INCORPORATION

The undersigned, acting as incorporator, in order to form a Corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation for such Corporation.

#### ARTICLE I

The name of the Corporation shall be GREEN, INC.

#### ARTICLE II

The Corporation is to have perpetual existence.
