
CERTIFICATE OF INCORPORATION OF

That we, the undersigned, being three natural persons of full age, have this day voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and to that end hereby adopt articles of incorporation as follows:

ARTICLE I.

The name of the Corporation is THE GRANDE SALOON INC, an Idaho corporation.

ARTICLE II.

The purpose or purposes for which THE GRANDE SALOON INC., is organized is to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Idaho.
