The Idaho Secretary of State's Office has determined that grounds exist to administratively dissolve, cancel, or revoke the authority of the business entity named on the reverse. This is because, contrary to the law, the business entity failed to file an annual report by the due date.

To stop the administrative dissolution, cancellation or revocation of authority from proceeding, the business entity must, within 60 days, file an annual report on a form previously sent by the Secretary of State's Office.
