ARTICLES OF INCORPORATION

OF

MOUNTAIN STATES INSULATION & SUPPLY CO., INC.

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following articles of incorporation:

ARTICLE 1: NAME. The name of the corporation is MOUNTAIN STATES INSULATION & SUPPLY CO., INC.

ARTICLE 2: DURATION PERIOD. The period of duration of the corporation is perpetual.

ARTICLE 3: PURPOSES. The purpose of the corporation is to engage in the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE 4: STOCK. The aggregate number of shares which the corporation shall have the authority to issue is Nine Hundred (900), that all shares shall consist of one (1) class only, and that all such shares are without par value.

ARTICLE 5: PREEMPTIVE RIGHTS. Shareholders shall have preemptive rights as allowed in Idaho Code Sec. 30-1-26, subject to the limitations contained therein.

ARTICLE 6: REGISTERED OFFICE AND REGISTERED AGENT. The address of the corporation's initial registered office in the State

of Idaho is 546 West 21st Street, City of Idaho Falls, County of Bonneville, State of Idaho, 83402. The name of the corporation's initial registered agent at such address is Don Clayton Rankin.

ARTICLE 7: DIRECTORS. The number of directors constituting the initial Board of Directors is two (2) and the names and addresses of the persons who are to serve as Directors until the first annual meeting of shareholders or until their successors are elected and qualify are: Don Clayton Rankin, 3240 Chaparral, Idaho Falls, Idaho 83404, and Frank H.
