ARTICLES OF INCORPORATION

CHRIST CREED MINISTRIES, INC.

FIRST: The name of this corporation is CHRIST CREED MINISTRIES, INC. Its registered office in the State of Idaho is to be located at 515 - 20th Ave. North, in the City of Nampa, County of Canyon, and the registered agent in charge thereof is Rev. Joe J. Esparza, whose address is 515 - 20th Ave. North, Nampa, Idaho 83651.

SECOND: The nature of the business and the objects and purposes proposed to be transacted, promoted, and carried on are to do any or all the things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world, viz: This corporation is non-profit and the period of duration for the CHRIST CREED MINISTRIES is perpetual. Said corporation is organized exclusively as an interdenominal ministry to (a) obtain, by donation or otherwise, and provide any nature goods, commodities, clothing and services to the public at large in order to meet basic physical needs; (b) to minister to spiritual needs of the community at large, (c) to perform and make available any other services and religious activities needed to operate a ministry meeting the physical and spiritual needs of the community, (d) to solicit funds to continue the operation of the CHRIST CREED MINISTRIES as an exempt organization under section 501(c)(4) of the Internal Revenue Code of 1954 (or the corresponding provision of and future United States Internal Revenue Law.)

THIRD: The purpose of this corporation is to engage in any lawful act or activity for non-profit for which corporations may be organized under the general Corporation Law of Idaho.

FOURTH: The corporation shall not have any capital stock and the conditions of membership shall be stated in the by-laws.

SEVENTH: The activities and affairs of the corporation shall be governed by a board of directors, as stated in the By-Laws. The number of directors which shall constitute the whole board shall be such as from time to time shall be fixed by, or in the manner provided in, the By-Laws, but in no case shall the number be less than one.

EIGHTH: Meetings of the members and/or directors may be held without the State of Idaho, if the By-Laws so provide.

NINTH: The corporation reserves the right to amend, alter, change or repeal any provision contained in the certificate of Incorporation, in the manner now or hereafter prescribed by the statute, and all rights conferred upon members herein granted subject to this reservation.

TENTH: This corporation is organized exclusively for charitable and educational and ministerial/religious purposes within the meaning of Section 501 (c)(4) (Social welfare organization/religious activities) of the Internal Revenue Code.

Not withstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a tax exempt organization. This organization is not organized for profit and no part of the net earnings shall inure to the benefit of any private shareholder.

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a nonprofit fund, foundation or corporation which has established its tax exempt status under section 501(c)(4) of the Internal Revenue Code.

WE, THE UNDERSIGNED, being the incorporators hereinbefore named, for the purpose of froming a corporation pursuant to chapter 3, Title 30 of the Idaho Code, to make these Articles of Incorporation, hereby declaring and certifying that the facts herein stated are true and accordingly have set our hands and seals, this 6th day of December, 1984.
