ARTICLES OF INCORPORATION  
OF  
FEEDERS GRAIN SUPPLY OF PAUL, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned citizens and residents of the United States of America, and each over the age of 21 years, do by these presents voluntarily associate ourselves together for the purpose of forming a corporation as hereinafter states, pursuant to and under the laws of the State of Idaho, and do hereby execute and deliver these Articles of Incorporation for that purpose:

ARTICLE I

NAME

This corporation shall be known as "FEEDERS GRAIN SUPPLY OF PAUL, INC."

ARTICLE II

PURPOSES AND POWERS

The object and purposes for which this corporation is formed are as follows:

(a) To engage in the business of buying, selling, trading, dealing in, transporting, hauling, shipping and processing all types and kinds of grains, small seeds, and all other varieties and kinds of agricultural and farm products.

(b) To contract with producers for the planting, raising and harvesting of all types of grains, small seeds, and all other varieties and kinds of agricultural and farm products, and to take over, in whole or in part, the actual planting, raising and harvesting of such grains, small seeds, and all other varieties and kinds of agricultural and farm products.

(c) To buy, sell, trade and deal in any and all kinds of grain, small seeds, or other farm or agricultural products as broker, factor or agent of others as well as for

the account of the corporation itself.

(d) To transport, handle, store, clean, sort, grade or otherwise process any and all kinds of grain, small seeds and all other varieties of agricultural and farm products or commodities.

(e) To engage in the general warehousing business both as a public and private warehouseman of agricultural products and commodities, or other types of personal property, and to give bond and otherwise qualify and be licensed under applicable laws, either State or Federal, or both, applying to warehousemen, both public and private; to qualify when necessary or desirable for a license as a weigher, grader and inspector of agricultural commodities; to guarantee or furnish bond for individuals to be licensed and act as weighers, graders or inspectors of agricultural commodities under applicable laws.

(f) To engage generally in the buying and selling of any and all types and kinds of property as a wholesaler, retailer, dealer, factor, agent, consignee or trust receipt trustee.

(g) To engage in the business of farming and to engage in the business of raising, feeding or fattening any and all types of livestock, including but not limited to cattle, sheep, swine and poultry.

(h) To purchase, lease, own, sell, mortgage, sub-lease and otherwise acquire and dispose of lands, buildings, easements and all rights in real property as well as personal property which may be requisite for the purposes or are capable of being conveniently used in connection with any of the objects of this corporation, and to enter into, make, perform and carry out contracts of every sort and kind with any person and to acquire and take the good will, property, rights, franchises and assets of every kind and the liabilities of any person, firm,

association or corporation either in whole or in part and to pay for the same in cash, stock or bonds of the corporation or otherwise.

(i) To borrow money and otherwise obtain credit for the account of said corporation and to issue debentures or other evidences of indebtedness therefor and to obligate the assets of the corporation as security for such indebtedness; to act as surety and guarantor in any and all types of engagements including the power to execute, endorse and deliver contracts, and to guarantee the prompt and faithful performance and payment of debts, notes, agreements, contracts and the undertakings of any other person, firm, partnership or corporation: and including also the power to act as an accommodation, co-maker or guarantor of obligations either as primary or secondary obligor.

(j) In the purchase of or acquisition of property, business rights or franchises or for any other object in and about its business or affairs, to incur debt and to borrow and secure the payment of money in any lawful manner including the issue and sale or other disposition of bonds, debentures, notes and other evidences of indebtedness.

(k) Without in any particular limiting any of the objects or purposes of the corporation above set forth, the business or purposes of the company shall be from time to time to do any one or more or all of the acts and things herein set forth and to do any and all such other acts and things and business in anyway connected therewith or auxiliary thereto, or necessary or convenient to the performance of the same, and in the performance of such acts said corporation shall have legal power and authority to do any and all of the things above set forth as well as such other power and authority as may be given it by law.

### ARTICLE III

#### EXISTENCE

This corporation is to have perpetual existence.

### ARTICLE IV

#### PLACE OF BUSINESS

The location and post office address of the registered office of the corporation is Paul, Minidoka County, Idaho.

### ARTICLE V

#### STOCK

### ARTICLE VI

#### CHARACTERISTICS OF STOCK

The holders of common stock are entitled to all dividends declared by the Board of Directors; each stockholder of common stock of record shall be entitled at all meetings of the corporation and in any matters requiring a vote, to one vote for each share of stock standing in his name upon the books of the corporation.

The Board of Directors need not be holders of common

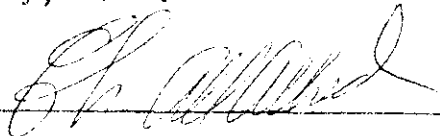
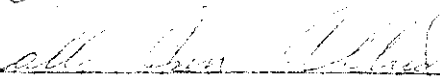

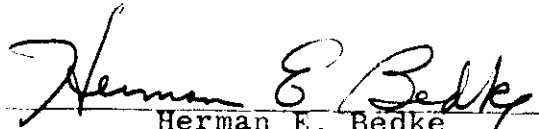
