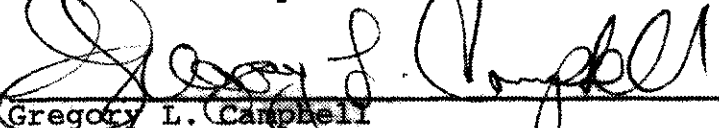
Paragraph 7 is amended to read "The Limited Partners shall make additional contributions to the partnership when called upon.

Said original Certificate as twice amended is otherwise ratified and affirmed.

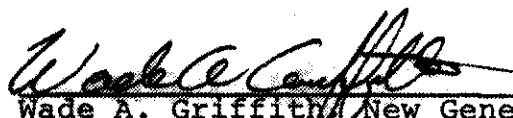

IN WITNESS WHEREOF, the undersigned have executed this third certificate of amendment this 24th day of October, 1983.

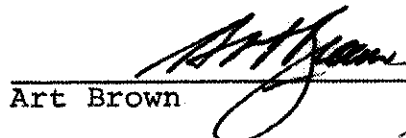

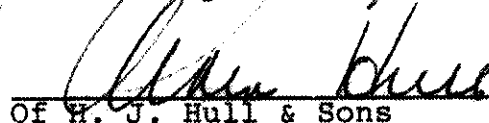

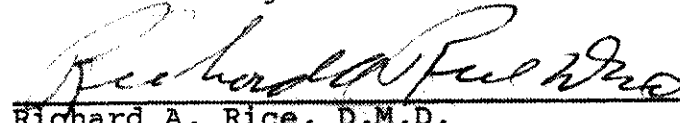
