ARTICLES OF INCORPORATION of

PRO-START, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is PRO-START, INC.;

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on February 11, 1994, in the manner prescribed by the Idaho Business Corporation Act:

"RESOLVED, that the first sentence of article FOURTH of the Articles of Incorporation of the Corporation be, and it hereby is, amended and restated in its entirety to read as follows:

FOURTH: (a) The aggregate number of shares that the Corporation shall have authority to issue is 3,000,000 shares of common stock without par value."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 853,333; and the number of shares entitled to vote thereon was 853,333.

FOURTH: The number of shares voted for such amendment was 733,333; and the number of shares voted against such amendment was 0.
