ARTICLES OF INCORPORATION

The undersigned acting as the incorporator of a corporation under the Idaho Business Corporation Act §30-1-101 et seq., adopts the following Articles of Incorporation for Morris Enterprises, Inc.

Article One

The shareholders of this corporation shall not be liable to the creditors of this corporation for any corporation indebtedness or obligation; and the shares issued shall not be subject to assessment for the purpose of paying expenses of this corporation incurred in conducting its business.

Article Eight

The directors of this corporation shall not be liable to this corporation or to its shareholders for money damages, losses or claims resulting from actions taken, or for the failure to take any action, as a director, except for that specific liability arising from a financial benefit received by a director to which he is now entitled, an intentional infliction of harm to this corporation or its shareholders, or an intentional violation of criminal law. Additionally, the corporation is permitted to indemnify its directors as to individual liability except as to those matters proscribed by Idaho law.

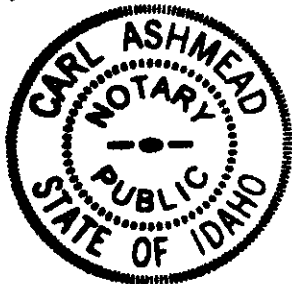
