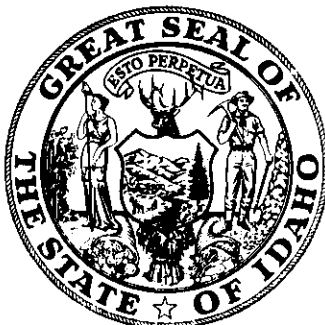

ARTICLES OF AMENDMENT

COMES NOW, **SANDPOINT WINDOWS & DOORS, INC.**, an Idaho corporation, acting by and through its duly elected officers and with the unanimous consent of all shareholders and the Board of Directors of said corporation and does hereby adopt Articles of Amendment to its Articles of Incorporation, as specified by Idaho Code 30-1-61, as follows:

1. The current name of this corporation is Sandpoint Windows & Doors, Inc.

2. The Amendment to the Articles of Incorporation of Sandpoint Windows & Doors, Inc. is to change the name of said corporation to MARSAC, INC.

3. The date of the adoption of this amendment by the shareholders and the Board of Directors was November 15, 1994.

4. The number of shares outstanding is 200, all of which were entitled to vote on this amendment. No outstanding shares are entitled to vote as a class.

5. The vote of shares to adopt the Amendment to the Articles of Incorporation as herein set forth was unanimous.

7. This Amendment does not affect a change in the amount of stated capital of the corporation.
