ARTICLES OF INCORPORATION

OF

PAYETTE RURAL FIRE DEPARTMENT, INC.

Know all men by these presents, that we, the undersigned, being over the age of majority and all citizens of the United States of America and residents of the State of Idaho, do hereby voluntarily associate ourselves together for the purpose of forming a non-profit corporation, under and by virtue of the laws of the State of Idaho, and we do hereby certify:

Τ.

That the name of the corporation shall be and is Payette Rural Fire Department, Inc. $\,$

II.

That the corporation shall have perpetual existence.

III.

That the purpose and objects for which the corporation is formed are:

- (1) To have an organization, men and equipment necessary to protect the rural areas from loss by fire;
- (2) To protect from fire and the loss thereof, property owners and holders within our area of operation;
- (3) To promote and encourage cooperation between the different fire departments and organizations in the area;
- (4) To acquire by purchase, lease or otherwise, real or personal property necessary and convenient for the purpose of providing fire protection in the area served by this corporation;
- (5) To sponsor, promote or encourage activities to raise the necessary funds for maintaining the proper equipment and facilities for such fire department.
- (6) To enter into agreements with cities or municipalities regarding joint fire protection and use of equipment.
