#### ARTICLES OF INCORPORATION

OF

JOHN M. UKICH, D.D.S., P.A.

I, JOHM M. UKICH, of legal age and duly licensed under the provisions of Title 54, Chapter 9, Idaho Code, to practice dentistry as therein defined in the State of Idaho, for the purpose of forming a professional service corporation pursuant to Title 30, Chapter 13, Idaho Code, do hereby certify:

## ARTICLE I,

That the name of this corporation shall be:
"JOHN M. UKICH, D.D.S., P.A."

### ARTICLE II.

That the duration and existence of this corporation shall be perpetual.

#### ARTICLE III.

That the purposes of this corporation as formed are as follows:

To engage in every phase and aspect of rendering the same professional services to the public that a dentist, and particularly one specializing in the practice of pedodontics, duly licensed under the laws of the State of Idaho, is authorized to render; that such professional services shall be rendered only through individuals authorized by the laws of the State of Idaho to render such professional services as individuals.

To invest the funds of the corporation in real estate, mortgages, stocks, bonds or any other type of investment and to own real and personal property necessary for the rendering of professional services.

To do everything necessary and proper for the accomplishment of any of the purposes and all other acts permitted by the applicable laws of the State of Idaho.

### ARTICLE IV.

That the location of the office of this corporation shall be 1717 Lincoln Way, Coeur d'Alene, Idaho, and its registered agent at that address shall be JOHN M. UKICH, D.D.S.

## ARTICLE V.

That the total authorized stock of this corporation shall be 250 shares of \$100.00 par value each, all of one class which shall be designated common stock.

#### ARTICLE VI.

That the said JOHN M. UKICH is the sole and original Incorporator, Shareholder and Director of this corporation, and his address is 1717 Lincoln Way, Coeur d'Alene, Idaho, and that the said JOHN M. UKICH is duly qualified and licensed as a dentist under the provisions of Title 54, Chapter 9, Idaho Code, including the specialized practice of pedodontics.
