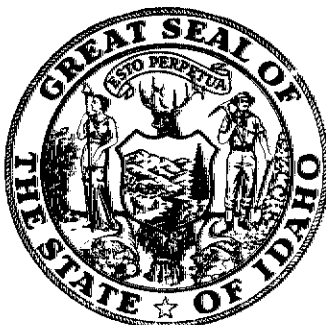

OF

The undersigned, acting as incorporator pursuant to Idaho Code Section 30-1-53, hereby forms the following professional service corporation, which shall be controlled by and have the powers enumerated in the Idaho Professional Service Corporation Act.

I

The name of the corporation is MARVIN BERNING, P.A.

II

The period of its duration is perpetual.

III

The purpose for which the corporation is organized is to engage in the practice of land surveying and allied professional services in the state of Idaho.

This corporation may not render such professional services except through its officers, employees and agents who are duly licensed or otherwise legally authorized to render such professional services in Idaho.

Only natural persons who themselves are duly licensed or otherwise legally authorized within the state of Idaho to practice land surveying may be shareholders. No person who is not a shareholder may serve as a director or general officer of this corporation, provided however, so long as the corporation shall have only one shareholder, the office of secretary may be held by a nonshareholder.

The aggregate number of shares which the corporation shall have authority to issue is 5,000 shares, consisting of one class only, and each share having a par value of one dollar.

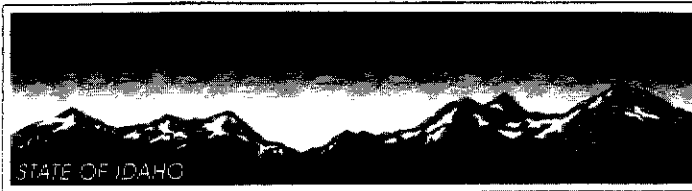
