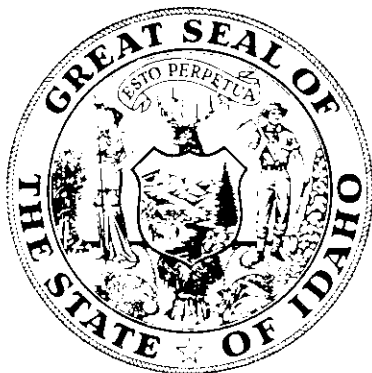

ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION OF
MARATHON METALLIC BUILDING COMPANY

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE

The name of the corporation is MARATHON METALLIC BUILDING COMPANY.

ARTICLE TWO

The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on February 1, 1982. Such amendment to the Articles of Incorporation is for the purpose of changing the name of the corporation.

The amendment alters or changes ARTICLE ONE of the Articles of Incorporation and ARTICLE ONE is hereby amended to read as follows:

"ARTICLE ONE

The name of the corporation is METALLIC-BRADEN BUILDING COMPANY"

ARTICLE THREE

The number of shares of the corporation outstanding at the time of such adoption was 55,000 shares of common stock and the number of shares entitled to vote thereon was 55,000 shares of common stock.
