

Certificate of Incorporation of the South Field Irrigation Company

This is to certify that the undersigned citizens of the United States hereby form themselves into a corporation under the provisions of an act of the Legislative Assembly of the Territory of Idaho, entitled "An Act concerning Corporations," approved, approved January 12th 1845, for the purpose of constructing and operating irrigating ditches and canals and the cultivation of the lands in connection therewith in Bear Lake County Idaho Territory.

First

The corporate name of this company shall be the South Field Irrigation Company.

Second

The object for which this company is organized is the construction of ditches and their operation in connection with the cultivation of the lands connected therewith.

Third

The amount of the capital stock shall be Five Thousand Dollars.

in shares of ten dollars each.

Fourth

The term of the existence of this Company shall be twenty five years.

Fifth

For the management of the concerns of this Company for the first three months the following named persons shall act viz: William Wey, William Hayward and Francis Wilcox.

Sixth

The principal place of business for said Company shall be Paris Bear Lake County, Idaho Territory.
