VI.

VII.

The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under Idaho Statutes Title 30, Chapter 1, Part 3. Shareholders of the corporation shall not be liable for the debts of the corporation except as required by the laws of the State of Idaho.

VIII.

No director shall be liable to the corporation for money damages for any action taken, or any failure to take action, except liability for:

- (i) The amount of financial benefit received by a director to which he is not entitled;
- (ii) An intentional infliction of harm on the corporation or the shareholders;
- (iii) A violation of section 20-1-833, Idaho Code, or
- (iv) An intentional violation of criminal law.

IX.

The Corporation is required to indemnify directors for liability, as defined in section 30-1-850(5), Idaho Code, to any person for any action taken, or any failure to take action, as a director, except liability for:

- (i) The amount of financial benefit received by a director to which he is not entitled;
- (ii) An intentional infliction of harm on the corporation or the shareholders;
- (iii) A violation of section 20-1-833, Idaho Code, or


(iv) An intentional violation of criminal law.

X.

The provisions of the articles of incorporation shall be dependent upon facts objectively ascertainable outside the articles of incorporation in accordance with section 31-1-120(11), Idaho Code.
