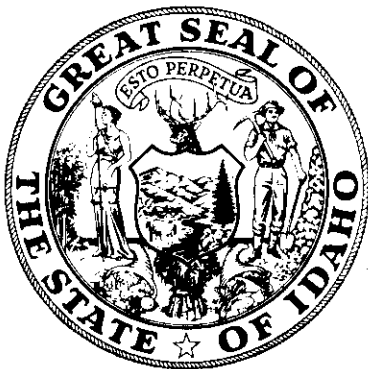

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation is Rocky Mountain Travel, Inc.

II.

The corporation is to have perpetual existence.

III.

The corporation is organized for the purposes of:

- a. To engage in, conduct, promote, advertise and carry on a travel service business, including arranging, planning and booking of worldwide passenger transportation, making reservations at hotels and resorts, land arrangements for tours and local transportation and conducting tours, on a commission basis or on a buy, sell or charter basis.
- b. to engage in any business related or unrelated to those described in clause a. hereof as may be from time to time authorized or approved by the Board of Directors of this corporation, and to engage in any activities and do all things as are incidental to or conducive to the attainment of any of the objects and purposes set forth in this paragraph;
- c. To be a promoter, partner, member, associate or manager of other business enterprises or ventures and to enter into any lawful arrangements for sharing profits and losses in any transaction or transactions, and
- d. For the purpose of transacting any lawful business or activity for which corporations may be incorporated under the laws of the State of Idaho as they may now exist or hereafter be enacted.

IV.

The authorized capital of the corporation consists of a single class of stock. The total number of authorized shares is 40,000 with a par value of \$0.10 per share and an aggregate par value of \$4,000.

V.

The address of the initial registered office of the corporation is, 1801 Homer Rd., Eagle, Idaho, 83616.

VI.

The name of the initial registered agent of the corporation at the corporate address is, Elaine C. Packer.

VII.
